## **VOLUNTARY ANNOUNCEMENT**

### **APPLICATION FOR REGISTRATION AND PROPOSED ISSUE OF RMB DEBT FINANCING INSTRUMENTS**

The boards of directors of Hang Lung Group Limited (“HLG”) and Hang Lung Properties Limited (“HLP”) announce that, on 22 September 2017, HLP (being a subsidiary of HLG) submitted a formal application to the National Association of Financial Market Institutional Investors (the “Association”) in the People’s Republic of China for registration and proposed issue of foreign non-financial enterprises Renminbi debt financing instruments in an aggregate amount not exceeding RMB10 billion (the “RMB Debt Financing Instruments”) in a single tranche or in multiple tranches at appropriate time(s) in the future (the “Application”).

Drafts of documents relating to the Application have been disclosed on the website of the Association (<http://zhuce.nafmii.org.cn/>).

It is uncertain whether and when approval of the Application will be granted by the Association. The proposed issue of the RMB Debt Financing Instruments may or may not proceed and, in the event it does proceed, timing, size and terms are still to be determined.
