

hello Members Exclusive Travel Rewards Terms and Conditions

1. This promotional / redemption event (the “**Event**”) is organized and operated under and part of the “hello Hang Lung Malls Rewards Program (hello 恒隆商場獎賞計劃)” (the “**hello Program**”), an integrated membership program managed and operated by Hang Lung Real Estate Agency Limited (“**HLREAL**”) (by itself and for and on behalf of Hang Lung Properties Limited) and which covers which covers Fashion Walk which is situated at Great George Street, Paterson Street, Cleveland Street and Kingston Street, Causeway Bay, Hong Kong, Peak Galleria which is situated at 118 Peak Road, Victoria Peak, Hong Kong, Kornhill Plaza which is situated at 1-2 Kornhill Road , Quarry Bay, Hong Kong, Grand Plaza which is situated at 625 & 639 Nathan Road, Mongkok, Hong Kong, Hollywood Plaza which is situated at 610 Nathan Road, Mongkok, Hong Kong, Gala Place which is situated at 56 Dundas Street, Mongkok, Hong Kong, Amoy Plaza which is situated at 77 Ngau Tau Kok Road, Kowloon Bay, Hong Kong, Printing House which is situated at 6 Duddell Street, Central, Hong Kong, Baskerville House which is situated at 13 Duddell Street / 22 Ice House Street, Central, Hong Kong, Standard Chartered Bank Building which is situated at 4-4A Des Voeux Road Central, Central, Hong Kong and 1 Duddell Street which is situated at 1 Duddell Street, Central, Hong Kong (collectively, the “**Hang Lung Mall(s)**”).
2. The Event is held between March 30 to May 31, 2023 (both days inclusive) (the “**Promotion Period**”).
3. The terms and conditions (the “**hello Program T&C**”) of the hello Program, including but not limited to Sections 5 (*Eligible Transactions*), 6 (*Registering Registered Spending and Earning hello Points*) and 7 (*Documentary Proof*) of the hello Program T&C, which can be accessed via the “Hang Lung Malls App (恒隆商場手機應用程式)” (the “**Hang Lung Malls App**”) or at www.hanglungmalls.com/en/tnc apply to the Event, save that in the event of any discrepancy or inconsistency between (i) the hello Program T&C; and (ii) these Terms and Conditions, (ii) shall prevail. Unless otherwise defined, capitalized terms defined in the hello Program T&C shall have the same meanings when used in these Terms and Conditions.
4. **The Event**

Event Mechanism
<p>Upon conducting and successfully registering in accordance with the hello Program T&C a single Eligible Transaction with a transaction amount of HK\$3,000 or more at the Hang Lung Malls, and by personally presenting a valid Travel Document (please refer to Section 4(ii) below for details) at the concierge counter located at Fashion Walk or Kornhill Plaza (the “Concierge Counter(s)”), a Member can redeem one (1) Airport Express Adult Round Trip Ticket Voucher (the “Adult Round Trip Ticket Voucher(s)”), provided that such Eligible Transaction is conducted during the Promotion Period.</p> <p>Each Member is entitled to redeem a maximum of one (1) Round Trip Ticket Voucher from the Event.</p> <p>A Member must personally present the valid Travel Document (please refer to Section 4(ii) below for details) at a Concierge Counter in order to redeem a Round Trip Ticket Voucher from the Event.</p>

- (i) In order to reach the transaction amount threshold, a Member can conduct at most one (1) Eligible Transaction and hence present at a Concierge Counter and/or upload through the Hang Lung Malls App at most one (1) sales receipt and corresponding electronic payment slip, provided that the Eligible Transaction is conducted at a Participating Merchant at a Hang Lung Mall during the Promotion Period.
- (ii) A physical or electronic flight ticket, boarding pass or flight itinerary that meets the following requirements constitute a valid Travel Document:
 - a) The place of departure must be Hong Kong
 - b) The destination must be places outside Hong Kong
 - c) The departure date must be within three (3) months from the date of redeeming the Round Trip Ticket Voucher
 - d) A valid flight number must be stated
 - e) The name of the passenger on the physical or electronic flight ticket, boarding pass or flight itinerary must be the same as the name of the Member registered under the Hello Program

HLREAL reserves the right to request from the Member any further documentary proof it deems necessary and may refuse to award the Round Trip Ticket Voucher to a Member at its sole and absolute discretion without any reason.

- (iii) A total quota of 400 Round Trip Ticket Vouchers (200 vouchers for Fashion Walk; 200 vouchers for Kornhill Plaza) to be redeemed under this Event apply and they are available for redemption on a first-come, first-served basis while stocks last.
- (iv) Under normal circumstances, all sales receipts and the corresponding electronic payment slips will be approved within fourteen (14) calendar days from the registration thereof. After such approval, one (1) e-redemption coupon for one (1) Round Trip Ticket Voucher will be issued and uploaded to a Member's "My Wallet" section in the Hang Lung Malls App. The validity of the e-redemption coupon is as follows:
 - a) If the Eligible Transaction is conducted between March 30 and April 19, 2023, the e-redemption coupon will be valid until May 1, 2023;
 - b) If the Eligible Transaction is conducted between April 20 and May 10, 2023, the e-redemption coupon will be valid until May 22, 2023;
 - c) If the Eligible Transaction is conducted between May 11 and May 31, 2023, the e-redemption coupon will be valid until June 12, 2023For actual validity, Members may refer to the instructions or terms and conditions stated on the e-redemption coupon.
- (v) Members must personally present the e-redemption coupon referred to in Section 4(iv) above and a valid Travel Document at the Concierge Counter within the validity period of such e-redemption coupon to redeem a Round Trip Ticket Voucher. Members should refer to the instructions in the Hang Lung Malls App for the redemption procedure. The e-redemption coupon for the Round Trip Ticket Voucher will not be reissued after its expiry. The Concierge Counter at Fashion Walk is open from 10:00 to 23:00 on Mondays to Sundays (including public holidays) and the Concierge Counter at Kornhill Plaza is open from 10:00 to 22:00 on Mondays to Sundays (including public holidays).
- (vi) The Round Trip Ticket Voucher will be valid until December 31, 2023. Members are required to redeem the physical Airport Express Adult Round Trip Ticket by presenting the Round Trip Ticket Voucher at the Customer Service Center located at designated Airport Express Station (Tsing Yi Station, Kowloon Station, Hong Kong Station or Airport Station) within the validity period as stated above. Members should refer to the

instructions on the Round Trip Ticket Voucher for the redemption procedure. The Round Trip Ticket Voucher will not be reissued after its expiry.

- (vii) Terms and conditions apply to the Round Trip Ticket Voucher and the Airport Express Round-trip Ticket. For details, please make enquiries with MTR Corporation Limited.
 - (viii) Eligible Transactions can also be conducted by Members with the benefits of other shopping privileges, including but not limited to those under “Birthday Bonus Point”.
5. HLREAL may stamp all sales receipts and electronic payment slips which are presented in person at a Concierge Counter. All sales receipts and electronic payment slips which have been presented at a Concierge Counter (whether stamped or not) or uploaded through the Hang Lung Malls App for registering Registered Spending, earning hello Points and/or participating in the Event will not be accepted again for the same purpose.
 6. If applicable to the Event, split payment transactions (i.e., transactions with multiple payment receipts and/or electronic payment slips for the payment of the same goods, services or the like issued by the same merchant on the same day) shall be considered as one single transaction. Therefore, the transaction amount on the sales receipts and the corresponding electronic payment slips must be the same.
 7. If applicable to the Event, if an Eligible Transaction is paid by installments, only the transaction in respect of the first installment will entitle the Member to participate in the Event.

HLREAL has the absolute right to use any photos, films, videos and records of the Event.
 11. Unless any Benefits are expressly and specifically stated to be supplied / provided / manufactured by HLREAL, the Benefits are not supplied / provided / manufactured by HLREAL. HLREAL does not in any way warrant the quality and condition of or any other matters in connection with such Benefits and shall not be held liable for the same. HLREAL shall not be held legally liable for any direct or indirect claims, demands, costs, charges, expenses, losses, damages and compensations arising out of or relating to such Benefits (including but not limited to the loss of Benefits due to the deletion of the Hang Lung Malls App, the termination of a Member’s Membership, the change of contact details of a Member, the use of such Benefits by mistake, network or device failures or problems, technical errors or any other reason) and the Event.
 12. HLREAL expressly welcomes its employees and staff members and its associated companies’ employees and staff members (collectively, the “**Staff**” and together with the Staff’s immediate family members, the “**Associated Persons**”) and their respective immediate family members to

join as Members and participate in the hello Program and the Event. HLREAL may at its sole and absolute discretion and at any time amend this Section 12 and deny the Associated Persons the right to join as Members and participate in the hello Program and the Event.

- 13.** HLREAL may at its sole and absolute discretion determine a customer's/Member's eligibility to receive any Benefits.
- 14.** HLREAL may at its sole and absolute discretion and at any time amend these Terms and Conditions or any aspect of the Event and/or withdraw or terminate the Event without prior notice.
- 15.** In case of any dispute regarding the Event or these Terms and Conditions, HLREAL reserves the absolute right to make the final decision and the decision of HLREAL shall be final and conclusive.
- 16.** By participating in the Event, customers/Members are deemed to have read, accepted and agreed to comply with these Terms and Conditions and accepted that HLREAL is entitled to the rights set out in such Terms and Conditions. In case of any breach of these Terms and Conditions, or HLREAL reasonably believes that dishonest or fraudulent conduct and/or acts have been committed by a customer/Member (including but not limited to using or abetting others to use inappropriate methods to affect, cause technical problems or disorder to, damage, interfere, interrupt or jeopardize the operation or any aspect of the Event or the hello Program), HLREAL has the sole and absolute discretion to immediately revoke the customer/Member's entitlement to any Benefits, demand and recover from any customer/Member the Benefits redeemed or equivalent value in cash, claim against the customer/Member for any damages and/or losses arising from or in connection with the above and pursue any legal action, without any prior notice.
- 17.** Due to unforeseen circumstances, force majeure events and/or circumstances not under the control of HLREAL, including, without limitation, acts of God, earthquakes, fires, floods, wars, civil or military disturbances, acts of terrorism, sabotage, strikes, epidemics, riots, power failures and computer failure, HLREAL may at its sole and absolute discretion and at any time amend these Terms and Conditions or any aspect of the Event and/or withdraw or terminate the Event without prior notice. HLREAL accepts no liability for the aforementioned amendments, withdrawal and/or termination. Under such circumstances, in case of any dispute arising out of the Event or these Terms and Conditions, HLREAL reserves the absolute right to make the final decision and the decision of HLREAL shall be final and conclusive.
- 18.** In case of discrepancies or inconsistencies between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

hello 會員獨家旅遊賞活動條款及細則

2. 活動於 2023 年 3 月 30 日至 5 月 31 日(包括首尾兩天)期間(下稱“活動期間”)舉行。
3. 恒隆商場手機應用程式(“Hang Lung Malls App”)中或 <https://www.hanglungmalls.com/tnc> 上的恒隆商場獎賞計劃條款及細則同樣適用於本次活動,包括但不限於第 5 項(合資格交易)、第 6 項(為登記消費及賺取 hello 積分)及第 7 項(文件證明),除非(i)恒隆商場獎賞計劃條款及細則之間存在任何差異或不一致,否則請予以保留;(ii)惟倘本條款及細則與恒隆商場獎賞計劃條款及細則有任何歧義,則以本條款及細則為準。除非另有定義,否則恒隆商場獎賞計劃條款及細則中定義的大寫字語在這些條款和條件中使用時具有相同的含義。
