If you post the Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not to affix a stamp when returning your Reply Form. Otherwise, please affix an appropriate stamp. If your email address provided is non-functional, until such time that a functional email address is received by the Share Registrar, you may (i) be unable to receive any notifications regarding the publication of Corporate Communications; and (ii) need to proactively check the Company's website at <u>www.hanglunggroup.com</u> (the "Company's website") and the website of Hong Kong Exchanges and Clearing Limited at <u>www.hkexnews.hk</u> (the "HKEX's website") to keep up with the publication of Corporate Communications.
